ATRIUS SWEEPSTAKES

OFFICIAL RULES

1. SPONSOR

The Atrius Development Group (“Promotion”) is sponsored by **Atrius Development Group**, 200 Congress Ave Suite 901 Austin TX 78701 (“Sponsor”).

2. ELIGIBILITY

Open to legal residents of the fifty (50) United States and the District of Columbia who are twenty-one (21) years of age or older at the time of entry. Void where prohibited by law and Atrius Development Group’s Restricted Shipping States.

Restricted States Include: **California, Connecticut, Colorado, Delaware, District of Columbia, Florida, Hawaii, Illinois, Maryland, Massachusetts, Minnesota, Nevada, New Jersey, New York, Oregon, Rhode Island, Virginia, Washington, and US Territories.**

Employees, officers, directors, and agents of Sponsor and their immediate family members or household members are not eligible.

3. PROMOTION PERIOD

The Promotion begins on **August 28th, 2026 at 12:00:01 AM PST** and ends on **September 30th, 2026 at 11:59:59 PM PST**. Sponsor’s server is the official timekeeping device.

4. HOW TO ENTER

A. Purchase Entry

During the Giveaway Period, purchase an eligible product(s) through (<https://atrius.dev/>).

Each eligible product purchased equals **(1)** base entry. If an order contains multiple eligible products, the entrant will receive **(1)** base entry for **each eligible product purchased**, up to the giveaway limit of **(5)** base entries per customer.

Purchase entries will be submitted automatically using the name and contact information associated with the order.

B. Alternate Method of Entry (AMOE) — Free Entry

To enter without making a purchase, hand-print your full name, mailing address, email address, phone number, and date of birth on a 3” x 5” card and mail it in a stamped envelope to:

Each valid mail-in entry equals **(1)** base entry. Each entry must be mailed separately in its own stamped envelope. A maximum of **(5)** mail-in entries per person is permitted during the entire Giveaway Period. Each mail-in entry must comply with these Official Rules.

Mail-in entries must be received by **September 30th, 2026**.

Incomplete, illegible, mechanically reproduced, photocopied, automated, or bulk-mailed entries will not be accepted.

ENTRY LIMIT

A **maximum of (5) base entries per person** is permitted during the entire Giveaway Period, regardless of entry method.

This limit applies to purchase entries, mail-in entries, or any combination of the two.

Examples:

- Five eligible FRS products purchased = five base entries
- Five valid mail-in entries submitted = five base entries
- Two eligible FRS products purchased plus three valid mail-in entries = five base entries

Entries submitted above the five-base-entry limit will be void.

MULTIPLIER EVENTS

Atrius Development Group may offer special multiplier events during the Giveaway Period. During a multiplier event, each qualifying base entry will receive the advertised number of drawing entries.

For example:

- One qualifying base entry during a 10X event = 10 drawing entries
- Five qualifying base entries during a 10X event = 50 drawing entries
- One qualifying base entry during a 20X event = 20 drawing entries
- Five qualifying base entries during a 20X event = 100 drawing entries

Multipliers do not increase the five-base-entry limit. They only increase the number of drawing entries awarded for a qualifying base entry.

PURCHASE ENTRIES DURING MULTIPLIER EVENTS

An eligible purchase will qualify for a multiplier when the order is placed during the advertised promotional period.

The purchase date and time shown in Atrius Development Group's order records will determine whether the entry qualifies.

MAIL-IN ENTRIES DURING MULTIPLIER EVENTS

A valid mail-in entry will receive the same multiplier when its envelope is postmarked on the applicable multiplier-event date.

Each multiplier mail-in entry must be sent separately and must follow all other mail-in requirements provided in these Official Rules.

GENERAL ENTRY CONDITIONS

Multiplier events apply only to eligible purchases made and valid mail-in entries postmarked during the applicable promotional period. Previously earned base entries will not receive a multiplier offered during a later promotional period.

The maximum of five base entries per person applies throughout the entire Giveaway Period.

Entrants may not use multiple names, mailing addresses, email addresses, accounts, identities, or other methods to exceed this limit.

All entries are subject to verification by Atrius Development Group.

A purchase will not increase your chances of winning. Void where prohibited.

5. ODDS OF WINNING

Odds of winning depend on the total number of eligible purchase and non-purchase entries received during the Promotion Period.

6. PRIZE

One winner will receive:

The maximum retail value (“ARV”) of the prize is **\$2,700.00**

7. WINNER SELECTION & NOTIFICATION

7A. Selection & Notification

The winner will be selected in a random drawing conducted by Sponsor on or about **October 2nd, 2026**. The potential winner will be notified using the contact information provided.

The potential winner will be notified via the contact information provided at entry. Upon notification, the winner must provide the Sponsor with their full legal name, address, and valid license details of a licensed Federal Firearms License (FFL) dealer in their jurisdiction of residence to which the firearm prize will be shipped.

7B. Background Check Requirement

To take possession of the firearm of the firearm prize, the winner must personally visit the designated FFL dealer, present valid government-issued photo identification, and successfully complete an ATF Form 4473 (Firearms Transaction Record), including passing any required National Instant Criminal Background Check System (NICS) or state-mandated background check.

7C. Transfer Fees & Local Expenses

The winner is solely responsible for any and all fees, taxes, or costs associated with the firearm transfer, including but not limited to FFL transfer fees, background check fees, and sales tax where applicable.

7D. Forfeiture & Disqualification

If the winner is not over twenty-one years of age (21) or is legally prohibited under federal, state, or local law possession of the firearm, fails the background check, fails to designate an eligible FFL dealer within 7 days of notification, or refuses to pay the required transfer fees, the prize will be forfeited in its entirety. No cash alternative, substitution, or monetary compensation will be provided in lieu of the firearm prize. All federal, states, and local gun laws apply.

8. TAXES

The winner is responsible for all applicable fees and taxes. Sponsor may issue IRS Form 1099-MISC if required by law.

9. GENERAL CONDITIONS

Sponsor reserves the right to disqualify any entrant who tampers with the entry process or violates these Official Rules. Sponsor may modify or cancel the Promotion if fraud, technical failure, or other factors compromise integrity.

10. LIMITATION OF LIABILITY

Sponsor is not responsible for lost, late, or misdirected entries or technical issues beyond its reasonable control.

11. GOVERNING LAW

This Promotion is governed by the laws of the State of Texas.

12. AGREEMENT TO OFFICIAL RULES
